PHOTOGRAPH REPRODUCTION SERVICES

USE / PERMISSION FEES

The RAC "Permission to Use Photographs" form must be completed in full and returned to the RAC before an order will be processed. Receipt of a completed form by fax will be sufficient to begin processing rush orders, but the signed original must be in hand before an order will be mailed.

The Permission that is granted by the Rockefeller Archive Center is for one-time use. Use of RAC images in any additional or subsequent editions of a publication will require the applicant to resubmit the Permission to Use Photographs form and pay all appropriate fees. For subsequent commercial use, there will be a \$50 per image charge.

All legal responsibility for observing applicable copyright laws, laws of libel and privacy, and laws governing property rights is assumed by the user. The user is responsible for obtaining the necessary permission and uses the photographs and/or film footage at his/her own risk.

The Rockefeller Archive Center reserves the right to limit or deny the use of its film and photograph material for use in any publication.

COST AND PAYMENT

Standard 8x10 or 5x7 copy prints, 35mm copy slides and copy transparencies of images in the collections of the Rockefeller Archive Center (RAC), are available for purchase and for scholarly, non-profit, or commercial use under the following conditions: The RAC does not sell original prints, original slides or transparencies and original or copy negatives from our collections. The RAC does not scan, or otherwise digitize any of the images in our collections.

Orders must be paid in full before the images will be mailed. Payment may be made by credit card or by check or money order (drawn in U.S. funds on a U.S. bank) made payable to The Rockefeller University.

The price for photographic reproductions is dependent upon several factors including: the cost charged to the RAC by the laboratories that reproduce images, commercial or nonprofit use of the image, and whether the researcher has visited the RAC to identify the images requested. The Archive Center uses different vendors at its locations in Sleepy Hollow and in Manhattan, and these vendors have different rates for their services. The vendor used for a particular order is not negotiable.

Commercial vs. Nonprofit Status

Nonprofit status will be determined by the ability of the customer to provide the RAC with a non-profit tax ID number for the company that is to be billed for the charges. The default billing rate will be the commercial rate.

Onsite vs. Offsite

The higher cost of images for offsite researchers reflects the additional RAC staff time required to identify and retrieve images for requests when the images have not been identified by the researcher.

RUSH ORDERS

A "rush order" is one in which delivery of the final product is expected within ten business days. The charge for rush orders is double the usual RAC charge + 30%
